How the LEA will Ensure Continuity of Services?

Regular health and safety screenings are in place as well as additional staff and observation added to help facilitate in-person learning.

Students' Needs:

Academic Needs	Academic deficiency notices are sent out weekly. Benchmark testing will take place within four weeks of the first day of school in both ELA and Math. Students who are both deficient and below the benchmark will receive interventions in the appropriate subjects via our Tutoring Program and differentiation in classes.
Social, Emotional, and Mental Health Needs	Our on-site counselor will provide training to staff and faculty on identifying social, emotional, and mental health needs of our students. There will be an online referral system set up for staff and faculty to communicate and record needs as they arise. Staff will continue to build relationships with, listen to, and observe students for signs for emotional or mental health distress. Teachers will communicate with the parents when such needs arise. Consultation with the school counselor may be advised and any external counseling sources recommended by counselor, if necessary.
Other Needs (which may include student health and food services)	Faculty and staff will continually receive first aid training on a monthly basis including but not limited to CPR, First Aid training, seizure/epilepsy training, etc.

Staff Needs:

Social, Emotional, and Mental Health Needs	Faculty and staff will have weekly meetings wherein a continual and consistent space will be created for sharing and checking in on these needs. Additionally, observations and an administrative "open door policy" will support these. We will also encourage an initial talking one-on-one with a school counselor, a referral to employee assistance, team-building opportunities, and personal care professional development when necessary.
